

### Sustainability Ratings



In order to be transparent with our customers about how sustainability is embedded in our processes, we absolve assessments by recognised third parties.

Diehl Metall takes part in the assessment of the Carbon Disclosure Project [CDP]. Now boasting more than 9,600 rated companies around the globe, the CDP maintains the largest and most comprehensive set of corporate environmental data worldwide and is considered the “gold standard” for environmental reporting.

Diehl Metall's strategic business units also use EcoVadis and NQC Supplier Assurance rating platforms to be assessed on sustainability topics via desktop audits.

The content of these interactive online questionnaires is based on official standards such as the principles of the UN Global Compact, the standards of the Global Reporting Initiative (GRI) or the ISO 26000 standard and covers topics such as the environment, labour and human rights, ethics and sustainable procurement.

### The minerals tin, tantalum, tungsten, gold

If a company purchases one of these four minerals, it can pose a social risk in the supply chain. Some of these come from mines in politically unstable areas. There, mining often leads to fundamental human rights violations, money laundering, corruption or the financing of armed groups.

In order not to indirectly support this, it is important that companies closely examine the origin of the minerals they purchase. Diehl Metall identifies and controls these risks by having the affected business units report on the origin of their metals using the Conflict Minerals Reporting Template [CMRT] - an official document of the Responsible Minerals Initiative. Customers can request this template from us at any time or use the download option on the company website.

### REACH & RoHS



REACH is the EU's chemicals regulation and governs the introduction, manufacture and use of all chemicals. It serves to protect human health and the environment. The regulation is in force in all EU countries and is based on the principle of greater responsibility of industry for the safe handling of its substances.

The EU RoHS Directive restricts the use of lead, cadmium, mercury, hexavalent chromium, polybrominated biphenyls (PBB) and polybrominated diphenyl ethers (PBDE) in certain electrical and electronic equipment (EEE).

Diehl Metall operates in conformity with these regulations. Please ask your contact person at Diehl Metall for the certificate.
