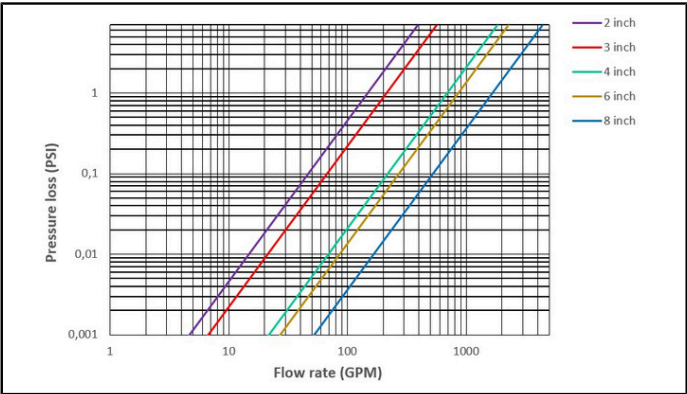

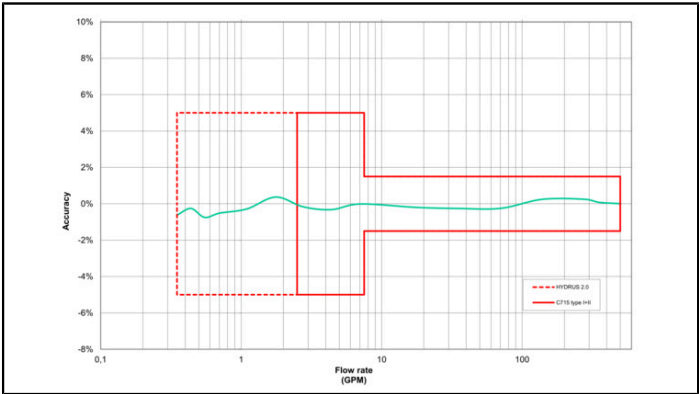

PRESSURE LOSS GRAPH / ACCURACY CURVE

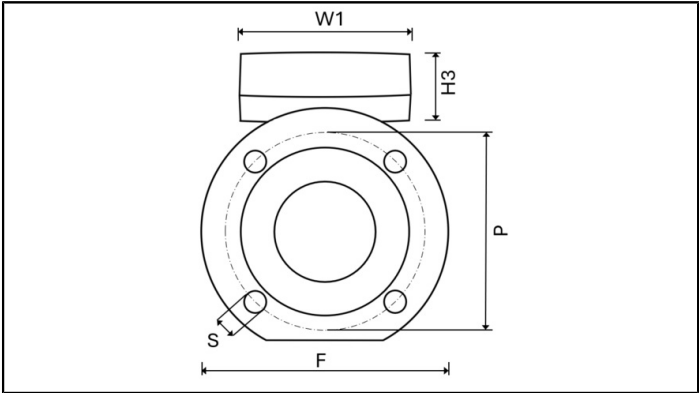
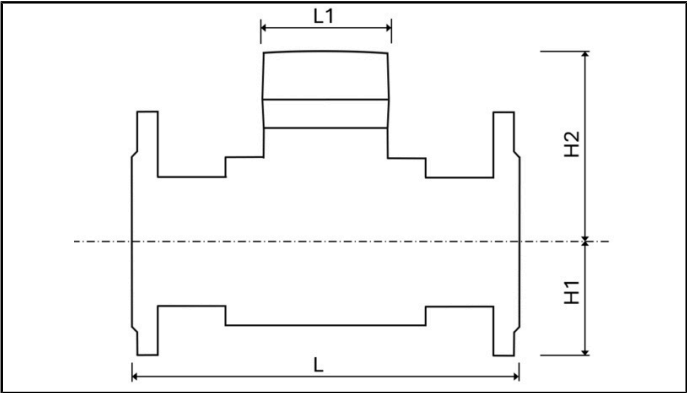


Pressure loss graph
